This research entitled "Using Projector To Improve Students' Learning Attention In English Subject Of The Eleventh Grade At SMA N 3 Langsa". Faculty of Tarbiyah and Teachers Training. State Institute for Islamic Studies (IAIN) Zawiyah Cot Kala Langsa.

The harness of technology developments, helps the students to learn their subject in new way. The educational units, such as, school, teaching methodology, and teachers should repaired the teaching process that is supported by technology applications and facilities.

CHAPTER I INTRODUCTION

A. The Background of the Study.

Classrooms have changed dramatically over the last decade with the advancement of new technology in teaching equipment. The rapid and constant changes in technology are creating both opportunities and challenges for schools. These two sides, the opportunities include greater access for students to learn interactively, and the challenges that considered by the school, are taking new way in the future concept of teaching learning.

The harness of technology developments, in teaching-learning above usefully helps the students to learn their subject in new way. Nowadays, the Indonesian educational committee posted about the SekolahStantardNasional that requires technology applications in the process of teaching. Moreover, the education unit, such as, school, teaching methodology, and teacher should provide the teaching process that is supported by technology applications and facilities. The technology applications are classified on the teaching-learning resources which are presented in interactive software, electronics textbooks, and tutoring videos. Furthermore, the facilities are classified here, on such as Wi-Fi access points, projectors, and so on. Thus, by harnessing these factors, it is expected that the learning process should run properly and contribute great outcome.

Actually, yet, teaching English in interactive way, which is supported by one of technology equipment, such as multimedia projectors, is not a new idea today. However, if it is provided with the supported equipment, it is not common for ordinary high schools in Langsa, Aceh. One the other hand, the school, which is able to provide this facility, is categorized as prestigious school. The prestigious school is the school that provides great categories in administration and academic process. Thus, it is expected to be leading institution in education.

SMA N 3 Langsa is the research location. As mentioned above, the reason why the school is selected because that it is prestigious schools in Langsa. It has great supported facilities, high-qualifications of the teacher and academic process. Furthermore, the school has requested high standards to be meeting in order to run its qualifications and objectives. There are three main indicators that signified the school to be recognized as different from other schools. The indicators are the schools policy, the qualifications of teacher, and the students' achievement.

These policies are meant to draw more attention from the students, which are lead to improve students' concentration in classroom. Furthermore, by using the projector, English is taught in virtual

teaching-learning environment, which is lead to increase English exposures to the students. Then, these environments are expected to be an authentic learning environment in the school.

The qualification of teacher, the second indicator is the backbone of academic process. They play important role to deliver the materials to the students. Their qualifications and experiments are vital to be considered by the school, if the first indicator applied successfully on practices. Furthermore, the teachers should be aware to have determination in improving their qualifications in back ground of qualification, continue their study for Doctoral Program, and actively in following seminars and workshops. These points are the strong supports. Then, nowadays, the teachers are requested to be certified based on their expertise, which is expected to attain the target of a professional teacher. According to the recent data of academic affairs of SMA N 3 and the DinasPendidikanKab/Kota Langsa has also confirmed that most of the teacher who teach at the school, have already certified to their own expertise by 2014. Thus, it is confirmed that, before the research is constructed, the teachers are qualified in their field, particularly, the teacher who taught English Subject. Actually, there are six teachers the three among of them have already certified, and acquired magisterial degree in education.

The students' achievements are the outcome of school policy management system and teacher qualifications. These indicators actually come forward as the results of the successfully education unit, which are organized orderly. As it can be seen on the national result of SMA N 3 examinations, students' aptitude, and skills'

inquiry, when it moves on the English Subject's marks, it's completely achieved in flying colors. The classroom process runs very well. It is indicated from well-motivated, greater concentration, and suitable teaching methodology that have been applied. Furthermore, the application of technology equipment, such as projectors, computer applications, and software in teaching English actually help maintain students' attention to the subject.
